The work to be done consists of furnishing all materials, equipment and labor necessary to construct the Adkins 60" Potable Water Transmission Main Phase I, consisting of the following approximate quantities: Approximately 30,900 LF of 60" Ductile Iron Pipe (DIP) Transmission Main, 517 LF of 20" DIP, 231 LF of 78" Steel Casing installed by jack and bore and all associated appurtenances.

Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, Contract Work Hours and Safety Standards Act and 40 CFR 33.240.

A Pre-Bid Meeting will be held at 9:00 AM, Thursday, June 1, 2023 at the Witty Adkins WTP at 173 Gap Hill Road, Six Mile, South Carolina 29682. Representatives of the Owner and Engineer will be available to answer questions. Contractors will be afforded a site visit during this time.

Bidder must be an official planholder for bid to be considered.

Bidders must deposit security with all bids. Security shall be in the form of a certified check or bid bond made payable to the Owner, and shall be for an amount equal to not less than five percent (5%) of the amount of the bid. Provisions of the security shall be as described in the Information for Bidders.

The project is being funded (in part) by a loan from the State Revolving Fund and therefore bidders must comply with all applicable State and Federal requirements identified in the contract documents including Davis-Bacon and America Iron and Steel provisions, BABA waiver was granted November 3, 2022. A requirement of this project is that prospective bidders must implement procedures that ensure disadvantaged business enterprise (DBE) firms are given opportunities for meaningful participation if subcontracts are awarded. The contractor must

follow the "good faith" strategies outline in the "Disadvantaged Business Enterprise" (DBE) compliance section of the Federal Requirements for SRF Funding.

Any prospective bidder, offeror, contractor or subcontractor who is aggrieved in connection with the solicitation of this contract may protest to Engineer or Owner in accordance with Section 11-35-4210 of the SC Code of Laws within 15 days of the date of issuance of the Notice of Intent to Award.

No bid will be considered unless the bidder is legally qualified under the provisions of the South Carolina Contractor's Licensing Law (South Carolina Code of Laws as amended on April 1, 1999, Chapter 11, Sections 40-11-10 through 40-11-428).

Contractors shall have a classification of WL5.

No bidder may withdraw the bid within 90 days after the actual date of the opening and thereof.

The Owner reserves the right to waive any informalities or to reject any or all bids.
